## Course Provisions

Training Day Academy LLC will provide a minimum of 24 hours of classroom instruction, 6 hours of (BTW) and 4 hours of observation time in a dual controlled automobile, fully insured, covering each student enrolled in the program. Classroom instruction must be a minimum of 3 weeks in length. (BTW) instruction shall not begin until the student has received at least 4 hours of classroom instruction. (BTW) instruction must be completed no later than 3 weeks after the classroom instruction has completed.

## Required Language

Notice: This provider is required to be certified by the Secretary of State. Completion of driver education instruction does not guarantee qualification for a driver license.

## Terms

1. The student must be at least 14 years 8 month by the first scheduled day of class (verification by birth certificate required)
2. Parent or Guardian agrees to pay the amount of \$325 which needs to be paid on or before the 1<sup>st</sup> day of class
3. Training Day Driver Academy LLC will accept Cash or Debit.
4. Requirements to pass course: Complete all homework assignments, have a minimum of 70% on all daily quizzes.
5. The required score to pass the State Test is 70%. Student will be given up to two additional attempts to pass the test.
6. There is a \$20 fee for lost or damaged text books.
7. In the event of a driving cancellation, a cancellation fee of \$25 will be charged.
8. A student may miss up to two days with a reasonable excuse (e.g. illness family matter). The days must be made up at the end of the class or in a future Segment 1 class.
9. At least two students will be in the driver education vehicle whenever behind-the-wheel instruction is provided.

## Refund Policy

If for any reason you decide to withdraw from the course before its completion, your refund will be based on the following:

- A. A full refund will be given if a student withdraws prior to the beginning of class.
- B. 50% refund will be given if a student withdraws prior to any Behind-The-Wheel instruction.
- C. Once Behind-The-Wheel instruction begins no refund will be issued.
